



## ASOHNS MEMBERSHIP FEES 2010

### Membership Types

#### e-Membership

Any member who elects to receive Society information electronically is an **e-Member**. Currently all types of membership receive annual subscriptions and the annual membership and the annual membership catalogue by post. **Corresponding** membership is offered as **e-Membership** only.

#### Non e-Membership

Any member who elects to receive information by post is a **non e-Member** and agrees to pay a surcharge of 10% of the e-Membership fee (before GST).

**Senior non e-Members** do not incur a surcharge for receiving information by post.

### Membership Classes

The Society's Constitution provides full details of membership classes. The information below is for quick reference only. Application does not guarantee election to membership.

#### Ordinary Member

Any practising OHN surgeon in Australia who has attained FRACS (or an equivalent qualification that is recognised by RACS and ASOHNS) is entitled to apply. Financial Ordinary Members have voting rights.

#### Corresponding Member

Any OHN surgeon practising outside Australia, who has attained FRACS or has connections in Australia, is entitled to apply. Application must include a Proposer and Secunder who are financial Ordinary Members of ASOHNS. Corresponding membership is 50% of Ordinary e-Membership and is only offered as an e-Membership. Corresponding members do not have voting rights.

\$525.00 GST does not apply

#### Associate Member

Any practising OHN surgeon in Australia who does not have a FRACS is entitled to apply. Fees are 75% of Ordinary e-Membership. Associate members do not have voting rights. **NB this category is currently under review.**

#### Life Member

Membership is by nomination, not application. Any Ordinary Member who has given outstanding service to the Society may be nominated for consideration. No fees are paid and the default type is e-Membership. Voting rights are retained.

#### Honorary Member

Membership is by nomination, not application. Any person who has made a significant contribution to the Specialty may be nominated for consideration. No fees are paid and the default membership type is e-Membership. An Honorary Member has no voting rights.

#### Senior Member

Any Ordinary member who is fully retired or has had 35 years' continuous financial membership is eligible for Senior Membership. Fees are 10% of Ordinary e-Membership and those who elect to be non e-Members will receive information by post and will not incur a surcharge. Senior members retain voting rights.

#### Ex-Officio Honorary Member

Office Bearers of other Societies as determined by Council may be, ex-officio, an Honorary Member. This is currently restricted to the President of NZSOHNS. No fees are paid and the default membership type is e-Membership. Ex-Officio Honorary members have no voting rights.
